## 1 Installation information

## 1.1 General

TB and TBE series are apparatus installed into standard EN/IEC60715 TH 35 DIN-Rail located in Safe Area or Zone 2 within the specified operating temperature limits (for complete details please refer to table 1). They can be mounted with any orientation over the entire ambient temperature range.

The end user is responsible to ensure that the operating temperature of the module is not exceeded in the end use application.

Units must be protected against dirt, dust, extreme mechanical (e.g. vibration, impact and shock) and thermal stress, and casual contacts.

Electrical connections are accommodated by polarized removable screw terminal blocks or fixed terminal blocks and customer dedicated connectors which can be plugged in/out into a powered unit without suffering or causing any damage. Connect only one individual conductor per each clamping point, use conductors suitable for size of each terminal block. Use only cables that are suitable for a temperature of at least 85°C. The wiring cables have to be proportionate in base to the current and the length of the cable.

TB and TBE series must be installed, operated and maintained only by qualified personnel, in accordance to the relevant national/international installation standards (e.g. EN/IEC60079-14 Electrical apparatus for explosive gas atmospheres - Part 14: Electrical installations in hazardous areas (other than mines)), following the established installation rules.

According to EN/IEC61010, TB and TBE power supplies must be connected to SELV or SELV-E supplies. All circuits connected to TB and TBE must comply with the overvoltage category II (or better) according to EN/IEC60664-1.

Failure to properly installation or use of the equipment may risk to damage the unit or severe personal injury. For those models having a relay output: connect relay contacts checking the load rating to be within the contact maximum rating. To prevent relay contacts from damaging, connect an external protection (fuse or similar), chosen according to the relay breaking capacity diagram from installation instructions (for complete details please refer to table 2, if present).

For those models having a transistor output: connect transistor contacts checking the load rating to be within the contact maximum rating (for complete details please refer to table 2, if present).

For those models having contacts rated more than 50 Vac or 75 Vdc: de-energize main power source (turn off power supply voltage) and disconnect plug-in terminal blocks before opening the enclosure to avoid electrical shock when connected to live hazardous potential.

Storage: If the unit is not installed directly on a system (parts for spare or expansion with long storage periods), it must be conveniently stocked. Stocking area characteristics must comply with the following parameters: temperature -45 to +80°C; humidity 0 to 95%.

temperature -45 to +80°C; humidity 0 to 95%. Vibration: no prolonged vibration should be perceivable in the stocking area to avoid loosening of parts or fatigue ruptures of components terminals.

Pollution: presence of pollutant or corrosive gases or vapours must be avoided to prevent corrosion of conductors and degradation of insulating surfaces.

### **1.2** Installation for zone 2 application

De-energize power source (turn off power supply voltage) before plug or unplug the terminal blocks or before servicing, unless area is known to be nonhazardous.

Warning: substitution of components may impair suitability for zone 2.

Electrostatic Hazard: to avoid electrostatic hazard, the enclosure of TB and TBE series must be cleaned only with a damp or antistatic cloth.

The enclosure provides, according to EN60529, an IP20 minimum degree of protection (or similar to NEMA Standard 250 type 1).

### 1.2.1 Special conditions for safe use

The equipment shall only be used in an area of at least pollution degree 2, as defined in IEC 60664-1. When installed in EU zone 2, the unit shall be installed in an enclosure that provides a minimum ingress protection of IP54 in accordance with IEC 60079-0. The enclosure must have a door or cover accessible only by the use of a tool.

### Only for TBE-D5001-HRT-003 series:

TBE-D5001-HRT-003 series shall only be used to mount one HART® Multiplexer Modem, 5700 series.

For hazardous locations, TBE-D5001-HRT-003 series shall only be installed in an interlocked enclosure. As an alternative the end-enclosure shall carry the following warning marking: "Warning - Do not remove or replace fuse when energized".

### Only for TBE-D5001-HRT-004 series:

TBE-D5001-HRT-004 series shall only be used to mount one HART® Multiplexer Modem, 5700 series. For hazardous locations, TBE-D5001-HRT-004 series shall only be installed in an interlocked enclosure. As an alternative the end-enclosure shall carry the following warning marking: "Warning - Do not remove or replace fuse when energized".

#### Only for TBE-D5001-HRT-005 series:

TBE-D5001-HRT-005 series shall only be used to mount one HART® Multiplexer Modem, 5700 series. For hazardous locations, TBE-D5001-HRT-005 series shall only be installed in an interlocked enclosure. As an alternative the end-enclosure shall carry the following warning marking: "Warning - Do not remove or replace fuse when energized".

#### Only for TBE-D5001-HRT-006 series:

TBE-D5001-HRT-006 series shall only be used to mount one HART® Multiplexer Modem, 5700 series. For hazardous locations, TBE-D5001-HRT-006 series shall only be installed in an interlocked enclosure. As an alternative the end-enclosure shall carry the following warning marking: "Warning - Do not remove or replace fuse when energized".

#### Only for TBE-D5001-HRT-007 series:

TBE-D5001-HRT-007 series shall only be used to mount one HART® Multiplexer Modem, 5700 series. For hazardous locations, TBE-D5001-HRT-007 series shall only be installed in an interlocked enclosure. As an alternative the end-enclosure shall carry the following warning marking: "Warning - Do not remove or replace fuse when energized".

### 1.3 Inspection, maintenance and repair

The unit cannot be repaired by the end user and must be returned to the manufacturer or his authorized representative.

If enclosure needs to be cleaned use only a cloth lightly moistened by a mixture of detergent in water.

## Warranty certificate

Subject to the conditions set out below, G.M. Int. warrants that the Goods supplied are new and will be free from material defects and correspond to the G.M. Int. published specifications at the time of the shipment.

Warranty is given by G.M. Int. subject to the following conditions:

- G.M. Int. shall be under no liability in respect of any defect in the Goods arising from any drawing, design or specification supplied by the Client;
- G.M. Int. shall be under no liability in respect of any defect in the Goods arising from fair wear and tear, willful damage, negligence, abnormal working conditions, failure to follow G.M. Int.'s instructions (whether oral or in writing), misuse or alteration or repair of the Goods;
- G.M. Int. shall be under no liability under this Warranty (or any other warranty, condition or guarantee) if the price for the Goods has not been paid by the due date in accordance with the agreed payment terms;
- 4. Warranty is not extended to parts, materials or equipment not manufactured by G.M. Int., in respect of which the Client shall only be entitled to the benefit of any such warranty or guarantee as is given by the manufacturer to G.M. Int.
- G.M. Int. shall be under no liability in respect of any repair made by unauthorized personnel because it may completely invalidate the safety characteristics of the Goods; Goods supplied under this Warranty cannot be repaired by third parties.

Any daim by the Client based on any apparent defect in quality or condition of the Goods or their failure to correspond with specification shall (whether or not delivery is refused by the Client) be notified to G.M.
