

COOKIE POLICY

What are cookies?

Cookies and similar technologies are very small text documents or pieces of code that often contain a unique identification code.

When you visit a website or use a mobile application, a computer asks your computer or mobile device for permission to save this file on your computer or mobile device and gain access to information.

Information collected through cookies and similar technologies may include the date and time of the visit and how you use a particular website or mobile application.

Why do we use cookies

Cookies make sure that while visiting our website you remain logged in, your preferences and technical settings will be saved, and the website keeps running smoothly. The cookies also ensure that we can see how our website is used and how we can improve it.

What type of cookies do we use?

Necessary cookies

These cookies are required for good functionality of our website and can't be switched off in our system.

Usually these cookies are set by your actions while requesting G.M. International services. Examples of these actions are logging in to the website and checking whether you are logged in, saving your language preferences, filling in forms or setting your privacy preferences. It is possible to set your browser to block these cookies, but some parts of our website may not work properly when these are blocked

Performance cookies

We use these cookies to obtain statistical information about our website. They are used for performance measurement and improvement.

This cookie category is also known as Analytics. Activities like page visits counting, page loading speed, bounce rate and technologies used to access our site are included in this category

Functional cookies

We use these cookies to enhance functionality and allow for personalization, such as documents browsing, videos playing and personalization of tools.

These cookies can be set by ourselves or by our third party service providers, whose digital services we have added. If you do not allow these cookies, some of these functionalities may not work properly

Targeting / Advertising cookies

Targeting cookies are set by third parties such as YouTube, Facebook, and Twitter, and are used to track user behavior, such as video playback or what has been viewed in tweets. If you do not consent to these cookies, you may not be able to watch some videos on the website or use social sharing functions. The collected data can be used by third parties to create a profile of the

user's interests and display targeted advertising on other sites. Targeting cookies do not directly store personal information, but rely on the unique identification of the user's browser and device..

How can I switch off or remove cookies?

You can choose to opt out of all but the necessary cookies.

In the settings of the browser, you can change the settings to ensure that all cookies will be blocked.

Most browsers provide you with an explanation on how to do this in browser "help pages".

However, if you block the cookies, it is possible that you will not be able to enjoy all the technical features our website has to offer and it may negatively affect your user experience.
