SIL 3 2-wire Active HART[®] Tx Current Repeater
DIN-Rail and Termination Board,
Models D5016SS, D5016SK, D5016DS, D5016DK



General Description:

The Current Repeater D5016 module is a high integrity analog input interface suitable for applications requiring SIL 3 level (according to IEC 61508:2010 Ed.2) in safety related systems for high risk industries.

It repeats a 2-wire active 4-20 mA current signal input floating circuit to drive a Safe Area load.

The module allows bi-directional communication signals, for HART® devices.

Mounting on standard DIN-Rail, with or without Power Bus, or on customized Termination Boards, in Safe Area or in Zone 2.

D5016SS: Single channel, source output. D5016SK: Single channel, sink output. D5016DS: Double channel, source output. D5016DK: Double channel, sink output.

Parameters Table

In the system safety analysis, always check the Hazardous Area/Hazardous Locations devices to conform with the related system documentation, if the device is Intrinsically Safe check its suitability for the Hazardous Area/Hazardous Locations and group encountered and that its maximum allowable voltage, current, power (U_i/V_{max} , I_i/I_{max} , P_i/P_i) are not exceeded by the safety parameters (U_o/V_o , I_o/I_{sc} , P_o/P_o) of the D5016 series Associated Apparatus connected to it. See parameters indicated in the table below:

When used with separate powered intrinsically safe devices, check that maximum allowable voltage, current (U_i/V_{max} , I_i/I_{max}) of the D5016 Associated Apparatus are not exceeded by the safety parameters (U_o/V_o , I_o/I_{sc}) of the Intrinsically Safe device, indicated in the table below:

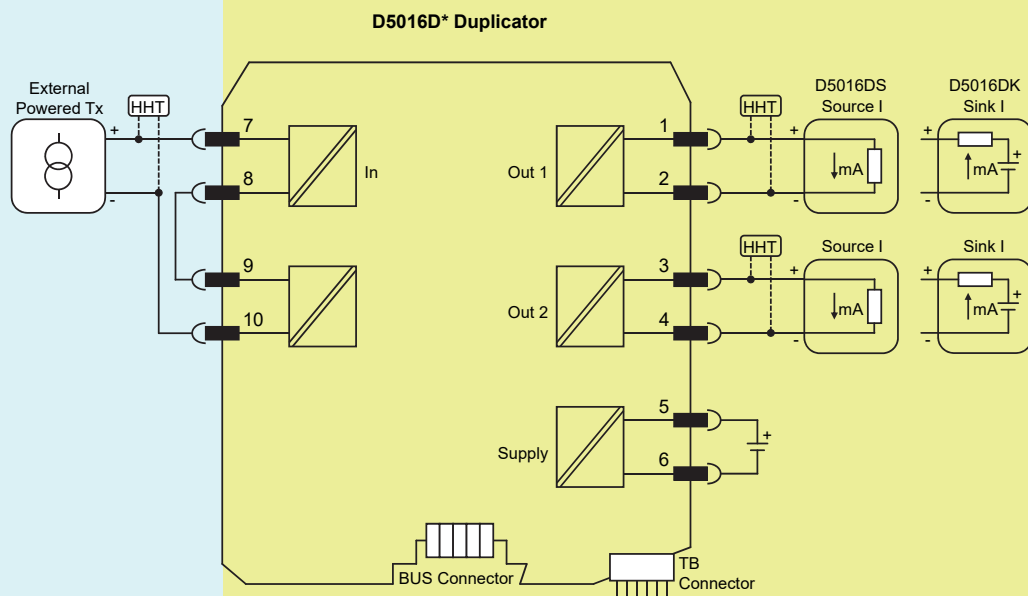
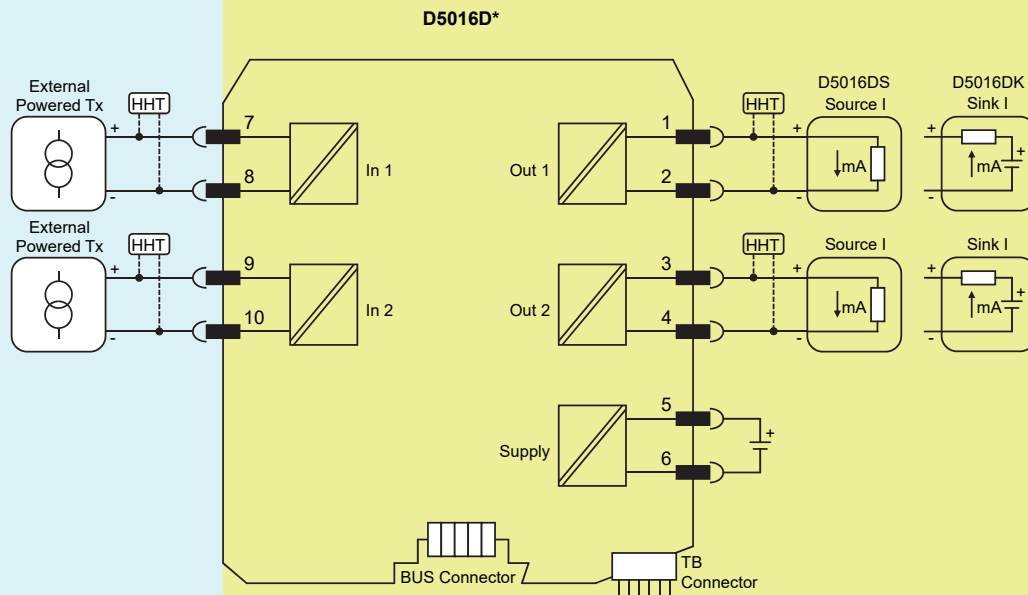
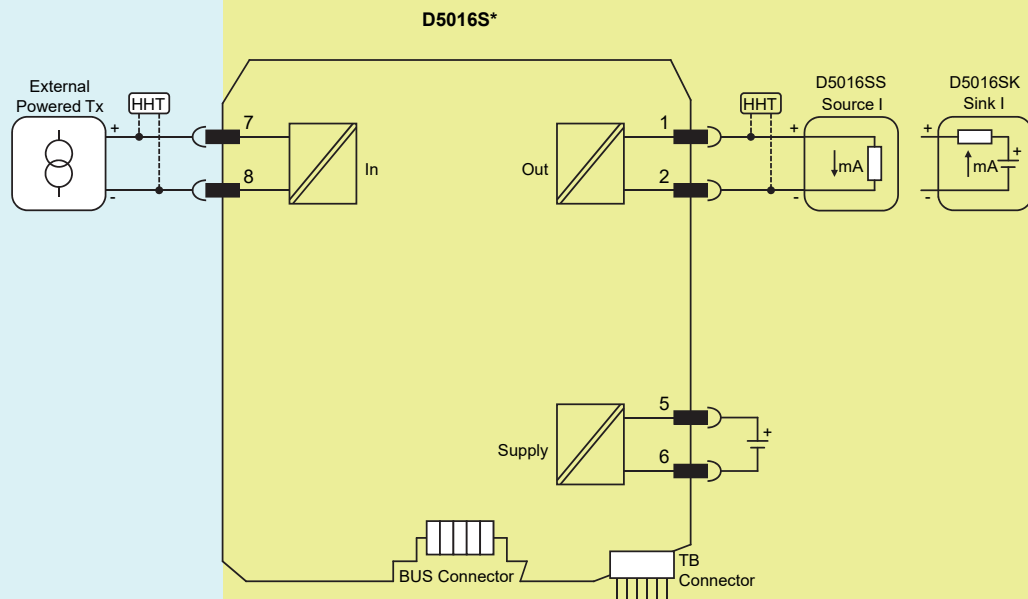

For installations in which both the C_i and L_i of the Intrinsically Safe apparatus exceed 1% of the C_o and L_o parameters of the Associated Apparatus (excluding the cable), then 50% of C_o and L_o parameters are applicable and shall not be exceeded (50% of the C_o and L_o become the limits which must include the cable such that $C_i \text{ device} + C \text{ cable} \leq 50\%$ of C_o and $L_i \text{ device} + L \text{ cable} \leq 50\%$ of L_o). The reduced capacitance of the external circuit (including cable) shall not be greater than $1 \mu\text{F}$ for Groups I, IIA, IIB and 600 nF for Group IIC. If the cable parameters are unknown, the following value may be used: Capacitance 200 pF per meter (60 pF per foot), Inductance $1 \mu\text{H}$ per meter ($0.20 \mu\text{H}$ per foot).

Warning

D5016 series are isolated Intrinsically Safe Associated Apparatus installed into standard EN/IEC60715 TH 35 DIN-Rail located in Safe Area or Zone 2, Group IIC, Temperature T4 or Class I, Division 2, Group A, B, C, D, T4 Hazardous Area within the specified operating temperature limits Tamb -40 to +70 °C, and connected to equipment with a maximum limit for power supply Um of 250 Vrms or Vdc.

Not to be connected to control equipment that uses or generates more than 250 Vrms or Vdc with respect to earth ground.

D5016 series must be installed, operated and maintained only by qualified personnel, in accordance to the relevant national/international installation standards (e.g. EN/IEC60079-14 Electrical apparatus for explosive gas atmospheres - Part 14: Electrical installations in hazardous areas (other than mines)), following the established installation rules, particular care shall be given to segregation and clear identification of I.S. conductors from non I.S. ones.

De-energize power source (turn off power supply voltage) before plug or unplug the terminal blocks when installed in Hazardous Area or unless area is known to be nonhazardous.

Warning: substitution of components may impair Intrinsic Safety and suitability for Zone 2.

Explosion Hazard: to prevent ignition of flammable atmospheres, disconnect power before servicing or unless area is known to be nonhazardous.

Failure to properly installation or use of the equipment may risk to damage the unit or severe personal injury.

The unit cannot be repaired by the end user and must be returned to the manufacturer or his authorized representative. Any unauthorized modification must be avoided.

Operation

D5016 repeats an externally powered 2-wire active 4-20 mA current signal input floating circuit to drive a Safe Area load.

The module allows bi-directional communication signals, for HART® devices. A "POWER ON" green led for each channel lits when input power is present.

Installation

D5016 series are Repeater power supply HART® compatible housed in a plastic enclosure suitable for installation on EN/IEC60715 TH 35 DIN-Rail, with or without Power Bus or on customized Termination Board. D5016 series can be mounted with any orientation over the entire ambient temperature range.

Electrical connections are accommodated by polarized plug-in removable screw terminal blocks which can be plugged in/out into a powered unit without suffering or causing any damage **(for Zone 2 installations check the area to be nonhazardous before servicing)**. Connect only one individual conductor per each clamping point, use conductors from 0.2 mm² (24 AWG) up to 2.5 mm² (13 AWG) and a torque value of 0.5-0.6 Nm. For USA and Canada installations, use only cables that are suitable for a temperature of at least 75°C. The wiring cables have to be proportionate in base to the current and the length of the cable.

On the section "Function Diagram" and enclosure side a block diagram identifies all connections.

Intrinsically Safe conductors must be identified and segregated from non I.S. and wired in accordance to the relevant national/international installation standards (e.g. EN/IEC60079-14 Electrical apparatus for explosive gas atmospheres - Part 14: Electrical installations in hazardous areas (other than mines)), make sure that conductors are well isolated from each other and do not produce any unintentional connection. Isolation in accordance with EN/IEC 60079-11 clause 6.3.13 is provided between non-intrinsically safe circuits and intrinsically safe circuits.

The enclosure provides, according to EN60529, an IP20 minimum degree of protection (or similar to NEMA Standard 250 type 1). The equipment shall only be used in an area of at least pollution degree 2, as defined in IEC 60664-1. When installed in EU Zone 2, the unit shall be installed in an enclosure that provides a minimum ingress protection of IP54 in accordance with IEC 60079-0. When installed in a Class I, Zone 2 Hazardous Location, the unit shall be mounted in a supplemental AEx or Ex enclosure that provides a degree of protection not less than IP54 in accordance with UL/CSA 60079-0. When installed in a Class I, Division 2 Hazardous Location, the unit shall be mounted in a supplemental enclosure that provides a degree of protection not less than IP54. The enclosure must have a door or cover accessible only by the use of a tool. The end user is responsible to ensure that the operating temperature of the module is not exceeded in the end use application.

Units must be protected against dirt, dust, extreme mechanical (e.g. vibration, impact and shock) and thermal stress, and casual contacts. If enclosure needs to be cleaned use only a cloth lightly moistened by a mixture of detergent in water.

Electrostatic Hazard: to avoid electrostatic hazard, the enclosure of D5016 series must be cleaned only with a damp or antistatic cloth.

Any penetration of cleaning liquid must be avoided to prevent damage to the unit.

Any unauthorized modification must be avoided.

D5016 series must be connected to SELV or PELV supplies.

All circuits connected to D5016 series must comply with the overvoltage category II (or better) according to EN/IEC60664-1.

Start-up

Before powering the unit check that all wires are properly connected, particularly supply conductors and their polarity, input and output wires, also check that Intrinsically Safe conductors and cable trays are segregated (no direct contacts with other non I.S. conductors) and identified either by color coding, preferably blue, or by marking.

Check conductors for exposed wires that could touch each other causing dangerous unwanted shorts.

Turn on power, the "power on" green leds must be lit, for 2 wires transmitter connection output signal should be corresponding to the input from the transmitter. If possible change the transmitter output and check the corresponding Safe Area output.
